#### **IMPORTANT NOTICE**

From the Franklin County Cooperative Health Improvement Program about your Prescription Drug Coverage and Medicare

<u>Please read this notice carefully</u> and keep it where you can find it. This notice has information about your current prescription drug coverage with the Franklin County Cooperative Health Improvement Program "Cooperative" and, your options under Medicare's prescription drug coverage. This information can help you decide whether or not you want to join a Medicare drug plan. If you are considering joining, you should compare your current Cooperative coverage, including which drugs are covered at what cost, with the coverage and costs of the plans offering Medicare prescription drug coverage. Information about where you can get help to make decisions about your prescription drug coverage is at the end of this notice.

#### When Can You Join A Medicare Drug Plan?

You can join a Medicare drug plan when you first become eligible for Medicare and each year from October 15th to December 7th. However, if you lose your current creditable prescription drug coverage, through no fault of your own, you will also be eligible for a two (2) month Special Enrollment Period (SEP) to join a Medicare drug plan.

## What Happens To Your Current Coverage If You Decide to Join A Medicare Drug Plan?

If you are currently covered by the Franklin County Cooperative Health Improvement Program drug plan and choose to join a Medicare drug plan, your coverage through the Cooperative will end. Your next opportunity to re-enroll in the Cooperative's prescription drug plan will be at annual open enrollment.

# When Will You Pay A Higher Premium (Penalty) To Join A Medicare Drug Plan?

You should also know that if you drop or lose your current coverage with the Cooperative and don't join a Medicare drug plan within 63 continuous days after your current coverage ends, you may pay a higher premium (a penalty) to join a Medicare drug plan later.

There are **two** important things you need to know about your <u>current</u> coverage and Medicare's prescription drug coverage:

- 1. Medicare prescription drug coverage became available in 2006 to everyone with Medicare. You can get this coverage if you join a Medicare Prescription Drug Plan or join a Medicare Advantage Plan (like an HMO or PPO) that offers prescription drug coverage. All Medicare drug plans provide at least a standard level of coverage set by Medicare. Some plans may also offer more coverage for a higher monthly premium.
- 2. The Franklin County Cooperative Health Improvement Program has determined that the prescription drug coverage offered by OptumRx is, on average for all plan participants, expected to pay out as much as standard Medicare prescription drug coverage pays and is therefore considered Creditable Coverage. Because your existing coverage is Creditable Coverage, you can keep this coverage and not pay a higher premium (a penalty) if you later decide to join a Medicare drug plan.



If you go **63 continuous days** or longer without creditable prescription drug coverage, your monthly premium may go up by at *least 1%* of the Medicare base beneficiary premium per month for every month that you did not have that coverage. For example, if you go nineteen months without creditable coverage, your premium may consistently be at least 19% higher than the Medicare base beneficiary premium. You may have to pay this higher premium (a penalty) as long as you have Medicare prescription drug coverage. In addition, **you may have to wait until the following October to join**.

Remember: Keep this Creditable Coverage notice. If you decide to join one of the Medicare drug plans, you may be required to provide a copy of this notice when you join to show whether or not you have maintained creditable coverage and, therefore, whether or not you are required to pay a higher premium (a penalty).
